Data storage

We would like to point out that in order to simplify the purchase process and for subsequent contract processing, the webshop operator stores the IP data of the connection owner in the form of cookies, as well as the name, gender, e-mail address, telephone number and address of the buyer and the products or services purchased.

Data related to payment processing, such as credit card number and bank details, are collected directly by the payment service provider we contracted as a processor.

The data you provide are necessary for the fulfillment of the contract or for the execution of pre-contractual measures. Without this data we cannot conclude the contract with you. The data will not be transferred to third parties, with the exception of the transfer of card data of

credit to the processing bank/payment service provider for charging the purchase price, to the logistics and transportation/shipping company we contracted to deliver the goods, to the company we contracted to operate the store website, and to our tax advisor for fulfilling our tax obligations.

After the cancellation of the purchase process, the data stored by us will be deleted. In case of entering into a contract, all data from the contractual relationship will be stored until the expiration of the tax retention period (7 years). Data on name, address, goods purchased, and date of purchase are also stored until the expiration of product liability (10 years). Data is processed on the basis of the legal provisions of § 96 para. 3 TKG and Art. 6 para. 1 lit. a (consent) and/or lit. b (necessary for contract fulfillment) of the GDPR.

General Browsing Data

When you use our website for information purposes only, i.e. if you do not register or otherwise provide us with information, we only collect data that your browser transmits to our server (so-called "server log files"). When you access our website, we collect the following data, which is technically necessary for viewing the website:

- The page of our website visited
 - Date and time of access
 - Amount of data sent in bytes
- Source/reference from which you reached the page
 - Browser used
 - Operating system used
- IP address used anonymously
